General Terms:

The Handler agrees to provide handling services for the above-named client to the following conditions:

1. All charges with respect to handling fees, bonuses, traveling expenses, entries' shipping fee, Veterinary work, medications or special diets are the owners' responsibility. The owner of the dog will assume all costs incurred by the handler for any medical treatment by a veterinarian required for the dog while under supervision of the handler. It is further agreed that the handler shall determine the need for any veterinary care for the animal while under their supervision. A credit card will be required to be on file for all clients who are boarding dogs with the handler to cover any emergency medical expenses. Veterinarian Bills MUST be paid before the animal leaves the Veterinarian office. If not paid, animal will stay in the vet's care until the bill is paid in full.
2. The handler, Angie Claussen, will exercise due diligence and precaution but, is not responsible for escape, self-inflicted damage, theft, illness, loss of animal, injury inflicted by other animals, or any unforeseen occurrences.
3. The handler also exhibits other dogs that she owns, co-owns, bred or co-bred. In case of ring schedule conflict, priority will be at the discretion of the handler. Owners that have supported the handler consistently and over the longest period of time will have priority. If necessary, a competent substitute handler will be secured to show your dog and the normal handling fee will be charged. In the event that no competent handler is available, the dog will be marked absent and no handling fee will be charged.
4. All dogs are expected to have a negative brucellosis test and be up to date on all required vaccinations including bordatella, flu and rabies. Client is responsible for providing monthly wormer and flea medicine.
5. All cash awards will be retained by handler.
6. All fees must be paid in full before the dog is released to the owner. A 10 % interest rate will be added to bills not paid after 30 days of the statement date and will accrue monthly until bill is paid in full. Any and all disputes regarding payment which cannot be agreed upon satisfactorily between client and handler will be settled in a court of law of handler's choice. It is further agreed that client shall pay any and all legal fees and court cost should the dispute reach this point. No dogs will be returned to client until the dispute has been resolved.
7. A \$25.00 charge will be assessed for all NSF Checks and client will be put on a Cash only basis.
8. Clients canceling bookings after the closing date of a show are responsible for the handling fees.
9. There will be an additional charge for exclusivity for your breed. Fees will be quoted.

10. Expenses are all travel costs incurred on a show weekend, divided evenly between each client. Expenses include, but are not limited to: dining expense, lodging expense, fuel expense, parking expense & grooming area expense.
 11. Unless otherwise stated, "Ringside" is defined as: *Dogs that are groomed (bath, trimmed, blow dried, and nails trimmed), healthy, free of parasites, ring trained, exercised, and ready to be shown at their best. They are to be presented to the handler with show lead and collar. Owner will be responsible for escorting them to the ring at the appropriate time.* Please notify us ASAP of your arrival at the show site.
 12. Any dog that requires extensive grooming (I.e. Aussies, golden) must be groomed by handler and pay a grooming fee, unless other arrangements have been made. This then makes them ineligible to be a "ringside" dog.
 13. All clients' dogs that reside with the handler (full-time) always have preferred status at shows over ringside pick-ups or part time clients.
 14. If a dog is entered and not shown because of inconvenience or personal reasons, the owner will be billed for normal amount of show and board.
 15. Client agrees to pay for all win pictures. Client can opt-out of win pictures but must notify handler beforehand.
 16. Client agrees to pay for an ad in one of the main dog show magazines if the dog wins Best in Show, Reserve Best In Show or Best of Breed at a National.

Boarding Terms:

1. All dogs residing with the handler, for handling services will require an upfront deposit of \$500.
2. Airport charge to pick up or deliver to Houston Intercontinental Airport (IAH) - \$150.
3. There will be a \$50.00 per hour charge for any trips to the Veterinarian.
4. There will be a \$0.55 per mile charge for dogs that are picked up or dropped off.
1. Training rate for all boarded puppies or dogs in need of training before being shown is \$25.00/day. Includes training and board.
